**UNAUDITED FINANCIAL RESULTS OF DONG-E-E-JIAO

On 24 April 2026, Dong-E-E-Jiao released its quarterly report for the three months ended 31 March 2026.

Dong-E-E-Jiao Company Limited (東阿阿膠股份有限公司) (“**Dong-E-E-Jiao**”) is a company incorporated in the People’s Republic of China. The shares of Dong-E-E-Jiao are listed on the Shenzhen Stock Exchange. As of the date of this announcement, Dong-E-E-Jiao is directly held as to 10.19% of its equity interests by China Resources Pharmaceutical Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) and approximately 23.50% is held by the Company through its non-wholly owned subsidiary, China Resources Dong-E-E-Jiao Company Limited (華潤東阿阿膠有限公司). The Group effectively controls approximately 23.50% of Dong-E-E-Jiao. Dong-E-E-Jiao is accounted for as a subsidiary of the Company.
